HOTĂRÂRE

privind rectificarea bugetului local de venituri și cheltuieli al comunei Horodniceni pe anul 2022

Având în vedere:

- a) prevederile Legii nr. 273/2006 privind finanțele publice locale, cu modificările și completările ulterioare;
- b) prevederile Legii bugetului de stat pe anul 2022 nr. 317 din 28.12.2021;
- c) prevederile Legii bugetului asigurărilor sociale de stat pe anul 2022 nr. 318/2021;

CONSILIUL LOCAL AL COMUNEI HORODNICENI adoptă prezenta hotărâre:
